4. Funded Hours

Before allocating your child's funded hours, please consider the following information:

- If your child is attending a specialist setting (eg. Early Years Language Class or Enhanced Early Years Provision), the specialist setting must be allocated enough funded hours to cover the total number of hours your child attends.
- Your child's allocation of funded hours should be in line with what is offered by their setting. Once you have allocated your child's funded hours, you will not be able to change your child's setting or reduce their funded hours until the end of each funding term.
- Your child can access up to 10 funded hours at a maximum of two childcare settings in a single day.
- If your child is eligible for both Universal/Two-Year-Old Funding **and** Working Family funding, the total hours accessed should be split equally between the types of funding. For example, if your child is accessing 20 hours of funding per week, you should allocate 10 hours of Universal/Two-Year-Old Funding and 10 hours of Working Family funding.
- Early Years Pupil Premium (EYPP) is paid for a maximum of 15 hours per week and will automatically be paid to the setting/s you have allocated Universal/Two-Year-Old Funding to, if applicable. If your child attends more than one setting and is not eligible for Universal/Two-Year-Old Funding, EYPP will be split proportionately based on the number of funded hours allocated to each setting.

I have been provided with clear information about the cost of any additional services and/or hours and understand that if I choose to access these, I will be required to pay.
